#### CAP FUND:

Proposed Legislation" "CAP" (Club Assistance Program) Fund otherwise known as the "CAP FUND": The facts:

1) There are 214,000 Registered snowmobiles in the state of Wisconsin

2) 60,000 of those belong to Snowmobile clubs of which those members- contribute by volunteering to mark, brush, maintain trails, groom etc.

**3**) The proposed legislation would attempt to make it a level playing field for all via... initiating a one time registration fee of \$15.00 and initiating a trail pass at the cost of \$35.00each for all to ride the trails. For those who belong to a

club would enjoy a \$20.00 discount. Actual cost for snowmobile club members would be \$15.00/season. Other than the one-time registration fee of \$15.00 which would be good for the life of the snowmobile, there wouldn't be any added increase for the snowmobile club member.

4) The Winnebago and other North East Wisconsin County Snowmobile Alliances are planning a bus trip of volunteers to take the day off during the week (i.e. a Tuesday or Wednesday or a Thursday those are the days that the house is in session) to visit Madison the state capitol in an attempt to lobby our state senators into taking serious consideration of the proposed CAP Fund legislation. \*Date of bus trip to be announced\*

**5**) If those of us currently supporting our local snowmobile clubs (approx 60,000 members) do not make the bus trip, you can bet that those other 154,000 free loaders will & they will not want to pay any more than they are already giving, which is nothing...including continuing "non support" of the trail systems.

In closing we all (us Snowmobilers) need to act now by doing our part and taking the day off of work and getting on that bus to Madison. If we don't the freeloaders will continue to enjoy our beautiful trails at the expense of the few active club members throughout the state. **Thank you in advance for your help and support!**
