Article 4- Section 2:

Elected office eligibility: A person must be an active member* in the Drifters Snowmobile Club for a minimum of 1 year before being nominated to an office position as a Board of Director, Trail Boss, Secretary or Vice President. A person must hold one of these 4 positions, or any combination of the 4, for a minimum of 2 years, to be eligible for a nomination for the following positions...Treasurer, and President. *An active member is a person who has attended at least half of the monthly meetings for the year and has participated in all of the Drifter's Snowmobile Club activities at least once. (Drifter's Snowmobile Club Activities include; Trail marking, Clayton fest, Backwards Raffle)
