Below is the FINAL new wording in our By-Laws:

Article 4- Section 2:

Elected office eligibility: A person must be an active member* in the Drifters Snowmobile Club for a minimum of 1 year before being nominated to an office position as a Board of Director, Trail Boss, Secretary or Vice President. A person must hold one of these positions before nomination for the following positions...Treasurer, and President. *An active member is a person who has attended at least half of the monthly meetings for the prior year and has participated in all of the Drifter's Snowmobile Club activities at least once. (Drifter's Snowmobile Club Activities include; Trail marking, Clayton fest, Backwards Raffle). Each elected official will continue to be an active member in the club.

Article 1- Section 2:

A new Drifters logo was added in conjunction with the retro Black and Gray shield.

The new logo will be blue DRIFTERS with snow on top of it and two snowflakes to the right of it.
